- VII. A motion was made to change the By-Law language for Article VII-Board of Directors, I. Meetings, first sentence to read: "All meetings of the Board of Directors shall be conducted with reference to Roberts Rules of Order". The motions was made by Deborah Fergus and seconded by Michelle Holtze. The motion passed.
- VIII. A motion to change the by-Law language for Life Members; "Article V-Membership, Section B, Classes of membership-Life Members" to read: "however only Senior Active Life Members shall be allowed to vote for the members of the Board of Directors." The motion was made by Sparky Bollinger and seconded by John Paccione. The motion passed.
- IX. A motion was made to leave the USJA Board of Directors at nine (9) members, with two (2) Director Vacancies that may be filled at a later date. The motion was made by Deborah Fergus and seconded by John Paccione. The motion passed.
- X. A motion was made to accept the Standards and Ethics Committee recommendation and conditions for reinstatement of Martinez. The motion was made by Deborah Fergus and seconded by Marc Cohen. The motion passed.

- XI. A motion was made to let USJA Legal Counsel develop a concussion protocol. The motion was made by Sparky Bollinger and seconded by Deborah Fergus. The motion passed.
- XII. A motion was made to immediately terminate the new promotion system and to continue using the USJA Senior Promotion system and to make an announcement on the USJA website, Growing Judo, and on Facebook. The motion was made by Deborah Fergus and seconded by Michelle Holtze. The motion passed.


