United States Judo Association Board of Directors Meeting December 4, 2010 La Verne, California

Present: Gary Goltz, President Joan Love, Vice President Marc Cohen, Secretary Bill Montgomery Roy Hash Dr. James Lally Katrina Davis, Executive Director Glenn Nakawaki, Corporate Counsel

Secretary, Marc Cohen declared that there was a quorum and asked President Goltz to open the meeting at 5:50 PM, Pacific Daylight Time.

Gary Goltz offered a welcome to the Board and guests.

Marc Cohen welcomed Barry Eisler to the meeting as an honored guest. Mr. Goltz went on to note that Mr. Eisler is an award winning international author, a Kodokan Shodan and noted that he emphasizes the use of Judo in his books and therefore introduces the art of Judo to millions of his readers throughout the world.

Gary Goltz presented the President's Report and began with an article from the New York Times about the seven reasons that people make purchases. He pointed out that item number 6, pleasure purchases and item 7, ego purchases were the two areas that drive membership dollars for the USJA. He continued the discussion by referring to the Judo Organization Triad statement that urged continued cooperation among the three Judo organizations.

A motion to accept the President's Report was made by Bill Montgomery and seconded by Roy Hash. The motion carried unanimously.

Katrina Davis, the Executive Director presented her report. Highlighted items included the fact that the USJA is in a slow time of the year in terms of member growth and that expense cutting measures are being explored. 62 new clubs have joined the USJA since last year. We had 120 sanctioned events during the current period. Dr. James Lally was, again the largest contributor to the USJA. (Report Attached)

In the absence of Paul Nogaki, Ms. Davis read the Treasurer's Report into the record. Marc Cohen requested clarification on the inventory asset and was given a satisfactory answer by Ms. Davis. A motion to accept both the Executive Director's Report and the Treasurer's Report was made by Dr. Lally and seconded by Gary Goltz. The motion carried unanimously.

President Gary Goltz invited Mr. Neil Simon, the President of the United States Judo Federation, and an honored guest to address the Board. Mr. Simon spoke about the recent USJF's recent Strategic Planning Session, which they hold every two years. He explained that during that planning session, he could see significant and palpable trust growing between the USJF and the USJA as well as being further established with USA Judo. He said that although there were some issues yet to be resolved, the barriers between the two organizations are coming down. There are monthly meetings between the two organizations when they work on joint projects, enhanced communications future plans for both entities. Gary Goltz, Neil Simon and Lance Nading meet once every 6 weeks to discuss issues. Furthermore, the three Presidents meet along with their Executive Directors about every 12 weeks to enhance the previous meeting. He went on to say that both the USJA and USJF are carefully vetting decisions concerning full and open cooperation with USA Judo.

Joan Love, Vice President then proceeded to deliver the Vice President's Report. She began the presentation with one of the committees that she chairs, the Club Support Services Committee, which was formerly a part of the Development Committee. One of its major activities is publishing the Growing Judo online magazine, which is growing and getting better all the time. Beyond the items that originally made up the magazine, items such as New Clubs, personal milestones and Dan promotions are included along with the feature articles. Among the highlighted goals of the magazine is to create revenue for the USJA by including commercial advertisements as we do on the on the USJA website.

Joan went on to speak about the Regional Coordinators Committee, which she also chairs. The goals of the Committee have not changed. Its mission is to have a network of people across the country that facilitate events in their areas and serve as a conduit for information. Joan thanked all the people in her committees for their hard work and contributions.

A motion to accept the Vice President's Report, which included the Club Support Services Committee and the Regional Coordinators Committee, was made by Dr. Lally and seconded by Bill Montgomery. The motion carried unanimously.

Roy Hash, Chairman of the Development Committee submitted his report. Roy introduced himself having assumed the Chair of the Committee in September of 2010. He stated that he had not received many requests for assistance for help in the previous three months, but he did get a report from Robert Byrd, who runs the training center in Atlanta. The report contained a monthly training schedule for that site and a myriad of monthly events that include player development and open mat sessions.

Mr. Hash went on to say that his focus for the next few months will be to reorganize, improve and reconstitute his Committee. His five key initiatives will be:

- 1. Reconstitute the Committee with new membership.
- 2. Provide a new and improved Committee Mission Statement.
- 3. Establish an internet video library of competitive techniques.
- 4. Work with Atlanta Training Center to develop a method of tracking competitive development and improvement.
- 5. Develop criteria and methods to increase the number of Regional Training Centers across the country.

A motion to accept the Development Committee Report was made by Joan Love and seconded by Dr Lally. The motion passed unanimously. (Report Attached)

Bill Montgomery, Chairman of the Coach Education Committee submitted his report. Bill began by saying that he is continuing to hold coach education sessions throughout the country. The goal is to have each presenter conduct at least two courses per year. Approximately 10 of the current presenters are using **Successful Coaching** as the academic text for the course. The goal for 2011 is to have all presenters use the text. The goal of getting the coaching course online has not gone as well as he wished, but he has a clear vision of what he believes to be the right way to do it. He asked for someone with advanced computer skills to assist him in brining the project to fruition. The basic manual has been completed, but needs additional work in order to bring it to its final stage.

Beginning in 2011, we will begin using the titles, **Assistant Coach**, **Coach** and **National Coach** for the levels. This will put the USJA in line with what the USJF is doing. He is also developing a list of texts for coaches to read so that they can enhance the course with further resources.

*Kelly's Capers* is making very good progress. In the past month and half, Mr. Montgomery received nearly 40 inquires for clinics. A schedule is being put together for 2011.

George Weers is editing the video from *Kelly's Capers* clinicians' training session (October, 2010) to create an instructional DVD to accompany future *Kelly's Capers* clinics, and online video clips to promote the program.

A motion to accept the report was made by James Lally and seconded by Roy Hash. The motion passed unanimously.

There was a call for discussion on the report. There being no discussion the motion was to accept the report by James Lally and seconded by Bill Montgomery. The motion was approved unanimously. (Report is Posted on Website)

Secretary Marc Cohen read a motion by Mr. Sid Kelly. The motion requested a Bylaw change that required candidate for the ranks of Hachidan, Kudan and Judan to have placed in two national events along with the requisite service points and any other written requirements regularly required by the Promotion Board. Secretary Cohen indicated that the motion should be tabled due to the fact that the Bylaws are in the process of being rewritten and will have provisions that will allow the individual committees to request their own operating procedures provided that they are approved by the Board of Directors. These proposed Bylaw changes will be submitted to the entire Board of Directors for review and possible approval in the summer of 2011. The motion was seconded by James Lally followed by discussion. Gary Monto stated that the same motion was brought before the Promotion Committee and was defeated in a committee vote.

Mr. Jesse Jones asked for clarification as to whether or not this was a motion brought by an individual and Mr. Cohen confirmed that it was exactly that. Mr. Jones then commented that he felt that the motion should be brought back to committee for further committee discussion.

Mr. Walter Dean also commented that he thought the motion should have stayed within the committee.

President Goltz made that statement that it is the right of any member to bring a motion before the Board. He noted that it took some courage to break with a group in order to give attention to an issue that he felt strongly about. Mr. Goltz feels strongly that it healthy for differing opinions to be brought forward and vigorously debated.

Joan Love requested that the motion be tabled for future consideration and further examination by the Promotion Committee. The Board then voted unanimously to table the motion.

In the absence of Committee Chairs or representatives, Secretary Cohen read the following Committee Reports into the record.

6. Women's Committee (Attached). Additional comments added by Joan Love. Ms. Love felt that some of the Chairman's comments were inaccurate; she had some concerns, which she discussed. Additional comments were made by Bill Montgomery with regard to Deborah Fergus' allegations of gender inequities in the coaching program.

A motion to accept each report was made, seconded and voted in favor of unanimously.

Gary Monto was asked to speak to the Board on the preparations of the forthcoming USJA / USJF Joint Junior Nationals scheduled for Toledo, Ohio this coming July 4<sup>th</sup> weekend. Mr. Monto explained that all of the scheduling was on time and that he is confident that the event will meet or exceed the expectations of both organizations and the participants. As this was an update, a motion to accept was not in order. Mr. Monto's statement is appended to the minutes.

Mr. Goltz announced that the bid for the 2013 Jr. Nationals has been approved. The event will be hosted by Eugene Kim in Pittsburgh, PA.

Mr. Hal Sharp was asked to comment on the upcoming revisions to the Junior and Senior manuals. Mr. Sharp gave insight into the thinking of the revisions and how they will focus on technical proficiency for the rank of Shodan and below. Both he and Sid Kelly are working diligently on a proposal to restructure the ranks and requirements to be more "user friendly" for students and teachers. The first draft of the proposal should be available within the next six to eight months. Nicholas Mechling was introduced to the meeting to discuss the website makeover via Miva Merchant that he paid for as a donation to the USJA. Mr. Mechling graphically demonstrated the face and functionality of the new site. Mr. Mechling said that he will be able to turn over the site to the USJA in about a week's time, but there would be additional work that needs to be done in loading data and working on navigation.

John Moe, our IT Director said that he was happy with the fact that content management would no longer come from a single source, but instead that authorized individuals such as committee chairs would have the ability to update their sections of the website.

Gary Goltz spoke about how the new site would seamlessly integrate with new security measures that we instituted with regard to data confidentiality and credit card security. Mr. Goltz also acknowledged the work time and expense that Mr. Mechling provided to the USJA without charge.

President Goltz then called for new business. No new business being offered, Mr Goltz called for a motion to adjourn. The motion was made by James Lally and seconded by Bill Montgomery. The motion carried unanimously and the meeting was adjourned at 7:50 PM.

# Summary: Seven basic reasons people spend their money

By Mary Hunt, November 22, 2010

- 1. <u>Need Purchases</u>. These are items you need to maintain life or to prevent physical misery. Included are basic food, shelter, medical care, basic clothing and taxes necessary to sustain life.
- 2. <u>Investment Purchases</u>. Included in this category are savings, checking accounts, stocks, bonds, 401(k) retirement accounts and other vehicles available for storing your funds.
- 3. <u>Convenience Purchases</u>. Goods and services to make life easier or to save you time and hassle. These can be household appliances, dry cleaning services, cell phones, computers and so on.
- 4. <u>Tradition Purchases</u>. This is a sickening category that includes any purchase made without rational thought, simply to be "normal." These are expenditures made so you'll "fit in" at work or home, items you almost never use, such as the "good" china.
- <u>Guilt Purchases</u>. This category is similar to Tradition Purchases, but the irrational motive here is guilt. Gifts given because you believe you must - because it is expected to meet others' expectations - are guilt purchases.
- 6. <u>Pleasure Purchases</u>. Goods or services that will bring pleasure, fun, excitement, happiness and intellectual stimulation into your life.
- 7. <u>Ego Purchases</u>. This category is really an evil spinoff of the Pleasure Purchases category. Ego purchases are status symbols and are made solely for the sake of showing off, e.g., oversize homes, expensive sports cars, giant plasma TVs things that come with big monthly payments that quickly suck away the pleasure.

#### **Conclusions:**

- 1. Each organization's resources are stronger working together than individually.
- 2. Without significant change, we risk extinction as a recognized US sport/activity.
- 3. All three organizations' goals and outcomes are similar enough to open opportunities to work together for the overall growth and improvement of US Judo.
- 4. All three organizations must work together, "shoulder to shoulder," in pursuing growth in all areas of judo; the only exception to this is USA Judo's legislated Olympic and International mission, which USJA and USJF can support.
- 5. All three organizations' need to embrace a model that emphasizes all aspects of judo and focuses on fulfillment of participant goals and objectives in addition to the existing competitive judo model.
- 6. The leadership of each of the three organizations need to create a significant change in perception for its membership (paradigm shift) from the previous competitive model to one of cooperation and collaboration.
- 7. The leadership of all three of our organizations need to build a sustainable interorganizational foundation that enhances long-term judo growth and development and allows for success of all three organizations.

We then asked our board members and elected officials for feedback before launching into any endeavors on these three items:

- 1. What you believe would be the best approach for marketing Judo in the United States?

- 3. The need to formally develop minimum National Standards that would be followed by all three main organizations initially regarding the screening process, membership rights (due process), and consequences for ethic violations.

In order to break down some of the current barriers between the organizations we are proposing the development of a category that may be called something like "joint member."

This type of membership is currently being offered between the USJF and the USJA and between the USJF and USA Judo.

- 1. If we can make it work financially without harming any of the organizations each will still retain their core membership. To join additional organizations a "joint status" a fee would be assessed.
- 2. That money would go to the additional organization(s) that your member would want to join.
- 3. That member has full rights of membership in other organization(s) with the core organization being responsible for the insurance coverage of the member.

(Example - How it works between the USJA and the USJF currently; members accessed additional fee of \$25 paid to the other organization.)

The need to formally develop minimum National Standards that would be followed by all three main organizations initially regarding the screening process, membership rights (due process), and consequences for ethic violations.

- 1. We already have these processes in tact.
- 2. The three organization's legal, ethics, and screening committees would create a recommendation that would need to be reviewed and voted upon by the appropriate bodies.
- 3. The next targets would be in the areas of rank requirements, coach certification, and other standard programs.

## Vice President's Report

#### **Club Support Services Committee**

The Club Support Services Committee was established in the spring of 2010. While the Development Committee continues to focus on programming and projects such as the Regional Training Centers, the Club Services Committee's purpose is to provide support and informational resources to USJA clubs and members through personal contact and referrals, the Regional Coordinator network, and electronic resources, including the *Growing Judo* online newsletter and others to be posted on the USJA website.

#### Accomplishments thus far:

Since February, 2010, the primary activity of this committee has been the production of the monthly online magazine, *Growing Judo*, which was previously a function of the Development Committee. Special emphasis has been placed on developing a more consistent format and professional appearance in the layout of the magazine. We have been gradually adding regular features that support clubs and USJA programming. These include *Judo News Around the Country, Upcoming Events*, and listings of newly established USJA clubs, newly certified coaches, and promotions from shodan and up. With the help of the Regional Coordinators, we are working to make the magazine more inclusive by soliciting contributions from a wider variety of USJA individuals and clubs. The assistance of the staff at the USJA National Office in compiling information for the magazine is very much appreciated.

Recent feature articles have covered events like the USJA/USJF Joint Junior Nationals, profiled noteworthy individuals, and presented new USJA programs like the Coaching Education Committee's *Kelly's Capers*. *Growing Judo* has also been used to provide useful information to clubs and members about topics like the USJA Coaches' Portal, the USJA State Awards Program, background screening policy and procedures, and new USJA merchandise.

## Future Goals

The Club Support Services Committee has several major goals related to the *Growing Judo*. These include utilizing the magazine to support USJA programs and efforts, such as the *Kelly's Capers* program, Visit-Another-Dojo-Month, and recruiting new Regional Coordinators; increasing the quality & diversity of contributions to the magazine; identifying other regular features that readers want, and designating individuals to be responsible for them. Additionally, we would like to assess whether USJA clubs and members are accessing the magazine and finding it helpful and informative, and gaining a better sense of the magazine's electronic circulation. Finally, we plan to implement procedures for including paid advertisements in the magazine, which would generate income for the USJA.

In addition, with a team of volunteers, the Club Services Committees intends to develop and post more electronic resources on the USJA website, such as articles on timely, helpful topics, useful databases (such as a clinicians list), and answers to FAQ's by members and clubs. Other proposed projects, such as forming a network for judo programs in schools, will also be explored. Our hope is to coordinate these efforts with the anticipated updating of the USJA website.

#### **Regional Coordinators Committee**

Established four years ago, this committee was formerly a subcommittee of "Development." However, it was recognized that this network of volunteers could be employed by many other committees and their projects. Furthermore, a number of people had difficulty locating the Regional Coordinators list on the USJA website when they needed it. As of spring, 2010, the Regional Coordinators was established as a separate committee in order to provide greater visibility & accessibility on USJA website.

#### **Purpose & Objectives**

The goal of this committee and its coordinators is to facilitate grassroots development at the local and regional level. A key task is to improve communication between USJA national committees & local clubs. Additionally, Regional Coordinators should contact and encourage <u>many</u> clubs & individuals to participate in & host judo events.

#### Accomplishments

Currently, 32 volunteers provide some representation to almost all of the "lower 48" United States. Regional Coordinators provide consistent support for USJA communication: distributing *Growing Judo*, publicizing initiatives like *Kelly's Capers*, *Visit-Another-Dojo-Month*, etc. Several Regional Coordinators are ensuring that their area is represented in the magazine, both in *Upcoming Events* and *Judo News*.

#### **Challenges & Concerns**

There are still some areas of the U.S. where there are no Regional Coordinators, and where we are still seeking volunteers. In addition, the level of involvement & activity of the Regional Coordinators varies substantially. Some of them have not been very active, either in facilitating events or in providing news & information.

It is also important that Regional Coordinators keep their job description in mind. Their role is to be facilitators, and not necessarily technical experts, clinicians, Sensei, or the hosts of all events.

#### **Ongoing Goals**

We hope to encourage more collaboration among neighboring Regional Coordinators, and to promote greater use of this network of volunteers by other USJA committees, and others (such as potential clinicians who might be traveling in their region), now that the committee list is more visible on the USJA website.

A key goal is to continue to augment and update the roster of Regional Coordinators. Over the next few months, inactive RC's will be contacted to determine who is still committed to the task. If these individuals are no longer able to donate their time and efforts, we will be seeking new volunteers and "Help Wanted" listings will be posted in *Growing Judo*.

## **Treasurer's Report October 2010**

The overall financial health of the organization going into the last quarter of 2010 continues to remain good and stable. Current assets as of the end of October 2010 were \$67,540 which includes the endowment fund. Current liabilities were only \$2.253. The current ratio is approximately a healthy over 20 to 1. A long term liability of \$16,406.06 was incurred in October for the cost of building the coaches' portal and database. This is to be paid down over the course of the next 17 months.

Revenue in October was \$34,346 and as expected with the largest portion being generated from membership fees. Expenses were \$53,141 including cost of goods. The expenses for October were unusually high due to the onetime cost of having the coaches' portal and database built. The net loss for October was \$19,019. The year to date income is (\$7,965).

## Coach Education and Development Committee report, December, 2010

We are continuing to hold coach certifications around the country. Ed Thebideau, John Paccionne and I have all conducted courses within the last four months. More are being scheduled for 2011. Our goal is to get each presenter to conduct at least two courses per year, they need not be full courses but can be subject specific, such as conditioning, drill draining for children, etc. These would all qualify as continuing education credits. About 10 of our approved presenters are using <u>Successful Coaching</u> as the academic text for their courses. The goal for 2011 is to have all our presenters using this text, for the classroom portion of each course.

My goal of getting the coaching program online has not progressed as well as I had hoped. Though I have a vision of what I would like to see, I really have no idea how to go about putting this thing together. Several people have suggested they would help, but thus far nothing has come to fruition. My computer skills are rudimentary, at best, initiating a comprehensive on-line examination, reference library and having a choice of DVD's to purchase is simply beyond my scope. I will have brought up in Executive Session the possibility of hiring someone to put the information onto the JA site or setup a link from the JA site. This is still a major

goal, but I do need some guidance from someone more expert in technology. And this is still a very worthwhile endeavor; we really need to get into the 21<sup>st</sup> Century.

The actual manual is done and needs to be incorporated with the specific requirements for each level, lesson plans, core skills, etc. Beginner with the new year we will start using, "Assistant Coach," "Coach" and "National Coach" as the titles for our levels. This will put us in line with what Hayward Nishioka is doing with the USJF. I am compiling an extended list of texts for the "National Coach" level. This level is where the coach should be delving into his/her own devices. I expect to have the basic manual and addendums finished by the end of January, 2011.

On a very positive note "Kelly's Capers" is making good progress. As you know a letter went out to each USJA Club and articles have been in *Growing Judo*. In the past month and a half, we have had almost 40 inquiries for seminars. An application form is being readied and will go out to everyone that has inquired. As we receive these back, a schedule will be put together for 2011. Tentative arrangements have been made for a few that will not require air travel; others will be scheduled later. In the long term, additional seminars specifically for presenters may be planned to keep them sharp on this process. If the initial response is any indication, we may be onto something. George Weers is editing the recorded information from the October clinicians' training session in Connecticut; the goal is to produce both a DVD and to post representative video clips online.

Hopefully, with the coaching certification that was completed yesterday, we have initiated a little different format. Though main points will normally be covered. Each individual presenter will add his/her own slant to the course. As with college courses, no two instructors emphasize the same things. Presenting the same material each time can turn the courses into robot sessions with little spirit. With this kind of variety it is hoped that people will see increased value in continuing education.

Though we have some formidable tasks, I am confident that with help from many sources we can accomplish our goals. The talent pool we have as an organization is extensive. Now, the solution may just be to ..."think globally and act locally," empowering each coach to act in the best interest of their students.

# **Kata Committee Report**

Dear Board of Directors,

I hope this meeting finds you all well!

Please excuse my absence from the meeting at this time and accept my report from the Kata Committee.

At this time I have much news to report. I would like to start with an inclusion of some information on the World Kata Championships held in Budapest. I would also like to thank Ms. Jolie Feng, who represented the U.S. at this Championship, for this information.

Although this was the fourth World Level Tournament, it was the second World Championship held by the IJF. Unlike past Championships, there were no limits to the number of teams, nor were there any qualifications necessary to compete. For 100 Euros teams could in up to three kata. There seemed to be more competitors, but it is hard to say whether this is due to growth of kata worldwide or the fact that there was no limitations on number of team, no qualification and a flat rate price to compete.

There was hardly any warning given to the teams in the U.S., which made it difficult for many of the U.S.' top teams to attend. The team of Ms. Jolie Feng and Ms. Terrie Norman, who have previously qualified and competed in the past World Kata Championship in Malta, were the only U.S. team to attend. At this event, Ms. Feng and Ms. Norman competed in both Katame-no-kata and Ju-no-kata. Also, the U.S. had three judges at the event: Dr. Takeuchi, Mrs. Eiko Shepherd and Mrs. Claudia Smith. Again, thanks to Ms. Feng for this information.

Moving back to the U.S., I am proud to state that since my last report there have been a number of kata clinics and certifications all over the U.S.

Dr. Charles of South Carolina has certified one club member in Nage-no-kata.

Mr. Fernandez and Mr. Bradley of California have taught a three day clinic in New Mexico covering Nage-no-kata, Katame-no-kata, and Ju-no-kata. There were approximately 15 certifications to B and C levels. They are planning on another clinic there within a year and Mr. Fernandez has plans to travel to Mexico to teach kata.

Mr. Schweizer of New York held a two week camp with 28 participants teaching Katame-no-kata and Itsutsu-no-kata. There were approximately 14 certifications to C level. He will also be holding judge certification at the Nakabayashi Tournament in New Rochelle, NY on November 28<sup>th</sup>.

The George Harris YMCA International Judo Camp in Huguenot, NY studied Goshinjutsu with Mr. David Kiang and myself this year and there were two certifications there.

Mr. Giunta and I have been working along with the Niagara Yudanshakai and held a clinic on Nage-no-kata and Katame-no-kata which was well received with approximately 20 participants.

Mr. Giunta and I were asked by Dr. Mel Applebaum to open the New York Open Championships with a demonstration of Nage-no-kata. This was quite reminiscent of Mr. Bregman and Mr. Nishioka at the All Japan Championship in the 60's and was very well received. It was a great honor!

In my last report, I stated that I was in hope that this committee would be able to "help to spread the practice of kata as it is a useful and interesting tool in the teaching Judo." I feel that the committee is doing an excellent job in trying to achieve this!

The Technical Officials committee is working on updating the web-page to more accurately reflect the number of committee members, clinicians, and technical officials.

In the past 6 months 3 new Technical Officials have been certified by Mr. Charles Schweizer (1 Level D and 2 Level C), in addition a certification exam is being held on November 28 at the Nakabayashi Cup tournament in New York by Mr. Charles Schweizer.

#### Vision:

To help develop, nurture and grow Women's Judo and encourage former players back to the mat to serve and help further growth of Women's Judo.

To encourage Sensei's, Coaches, Male and Female to take an active part in developing programs to recruit and maintain female players.

#### Mission:

To assist member clubs, Sensei, and Judoka and our Judo community create programs and atmospheres to increase their numbers. To use the research compiled to date to help in this mission.

#### Strategy:

To ask for contributions from all involved in Judo. We need to be pro active and work to provide continuous development of Junior, Senior and Master Females.

#### Goals:

1. To utilize the data to date to discover and correct the reasons for the low numbers of females entering and staying with Judo.

- 2. To create Sensei seminars and workshops to assist in developing Women's Judo Programs in their Communities. To discuss Women's development issues and improve their Female Membership.
- 3. Sponsor Women's Event's such as Clinics and Competitions (Gokyu no Waza, Kata, Coaches and Referee clinics, All Women's Championship).
- 4. Provide some help with entrance fees, transportation and accommodation reimbursement for competition and clinics for female Judoka who are limited by their financial shortfalls.
- 5. To provide each member club the necessary financial resources to put their Women's Programs into effect.
- 6. Provide unbiased and obtainable Rank advancement. Provide advancement of female Referees, Coaches and Clinicians

There is a lack of female participation in Judo. Part due to the lack of training of the trainers and lack of time effort and funds put forth to address the needs of females and why they do not stay.

#### The Need:

The needs are monetary in nature. The needs are ignorance of the, who, what, why, and where the women are and how to recruit and keep them on the mat. The need is for proper training of Instructors and Dojo Managers, male and female, on Women's Issues. The need is for Women's Clinics, Seminars, Tournaments and Events specifically for women. The need is for female Coaches, Referees, Clinicians, Competitors and fair advancement of Rank.

Unless there is some effort, incentive and help to participate in the above listed events, there will always be a shortage of women.

We completed the last of the Women's Competition events culminating with the 6<sup>th</sup> All Women's Championship in Bowling Green, Ohio. There are plans in the works for more FLAG Camps next year and the 7<sup>th</sup> All Women's will be announced soon.

In the past year we have realized a greater interest by both male and females in Growing Women's Judo. There have been a few both male and female that are still adamantly opposed to this endeavor and have written me to that fact. We will not be detoured.

Through the Kata, Referee and Coaches Clinics held this past year we have gained in both male and female certification. By having these clinics headed by females it allows more understanding and acceptance of female Judoka.

Questions for the Coaching and Development Committees have there been any discussions or plans or to put together a unit on the retention of women and girls within clubs, into their curriculum or is there a plan to add a section on both overt and covert discrimination in your curriculum? I brought this request up in my last report. I would like to get some feedback on this idea from the committee.

I have personally been e-mailing and phoning women to attend the same sanctioned events in their area as they cannot get matches if there is only one or two at an event. This idea could use some help from the coaches as they normally are the ones that plan the events for their competitors. Could the coaching committee work on something that would bring this to coach's attention?

What is reoccurring is that teams will have one female, so the coach does not make an effort to afford that female tournaments where she will get competition. I do understand the logistics but maybe with some support from Development, Coaches and other committees we can make some headway.
