### Item #2 Proposal for new rank requirements

Sid presented a proposal for the USJA rank requirements which moved some of the throwing tech. into a different order for the rank requirements. The proposal also removed the requirement that members do not need to compete to be eligible for rank promotion in the ranks from white through brown belt.

Also included in the proposal was to change the color of belts from brown to blue for sankyu and purple for nikyu. There was a new requirement added by this proposal that members seeking higher ranks should have to get signatures from judo people outside of the United States.

President Goltz made a statement in support of the entire proposal.
