EDITORIAL: YOU are a recreational player and we love you. Deal with it.

At the USJA Town Hall meeting in Connecticut a very insightful woman commented,

"I am 41 years old and started judo late. I am a brown belt. I will never be an elite competitor and I feel as if most people in judo place no value on me because of that. Being small, middle-aged and female makes that doubly so."

Is it true that we don't value recreational players? Speaking for myself, I would say that I do, very much so. One reason is that I know that people like this woman are much more likely to stay in judo, become a black belt and eventually teach the next generation than the 13-year-old who won the junior nationals this year. Think about the difference in persistence, maturity and just knowing your own mind that you have at 13 versus at 41.

As I told her, the people like me, who competed internationally and then stayed on to teach are RARE. I can think of hundreds of people I knew as competitors who have not been on a judo mat in years. Many of those who do still teach, such as Randy Rhodes in Missouri, I think Lee Naumann is still in judo - these were guys from my club but not household names or Olympic medalists. They were, if we were honest about it, recreational players.

Our recreational players are likely the real base of the pyramid and we better start treating them right. Our USJA board member, George Weers, once asked,

"What does the USJA offer that the average club coach really NEEDS?"

I would answer that we could offer programs to help develop their skills and those of their players. I was just on the phone with John Moe inviting him to bring players to a technique competition we will be hosting at the West Coast Judo Training Center. This program is funded by the USJA and USJF to be a development program. We often try out new ideas and host clinics with people from Sensei Okada to Chuck Jefferson to Richard Elizalde to Ronda Rousey. We have a new clinic coming up with sambo world medalist Roman Mitichiyan. All of these are just to teach more judo.

Back to the technique competition - this is for people to show what judo they KNOW, not how tough they are. Being tough and knowing judo can both happen in the same person, but they don't always. What if you start judo at 40 years old and have to go to work on Monday? Maybe you would like to be recognized for your technique and we certainly want you to have good technique because odds are you will be teaching the next generation. Maybe you are just 13 years old and would like to show off. I'll give more on the specifics in my next post.

Bill Montgomery, one of our incoming board members, said in his inimitably tactful manner,

"I have news for you people, ALL of our judo players in America with the exception of one or two, like AnnMaria's daughter, are recreational players. I hear people say, 'My son, Joe is an elite athlete.' No, he isn't. Your son Joe is ten years old! He still needs to be reminded not to wipe his nose on his sleeve. He is beating other ten-year-old orange belts- oh, excuse me, green belts - that is NOT an elite athlete. Almost ALL of our judo players are recreational. They don't work out seven days a week, 52 weeks out of the year. That's okay. I can accept that as long as they are good people. And, if they're not good people, we don't want them around anyway."

I agree with Bill completely. I see a lot of silliness with people asking me,

"Where should I take my 11-year-old to compete?"

I will say the same thing I always do ... You should take your child where he or she will have the most fun. I plan to hit the AAU Nationals this summer because Julia can visit her cousins and grandmothers in Missouri and I want to stay with her in a cabin and take her to swim in an honest-to-God river, which she has never done. Tournaments in between are primarily chosen based on whether we can stay at a hotel with a pool, because she needs to be a very capable swimmer by this summer. I can fish her out of a swift current, but I would rather not. Our other deciding factor is whether there is accompanying fun stuff - we are definitely hitting the All-Women's Tournament in Las Vegas in January (despite the name, competition starts at age five). My little girl has won the USJA junior nationals once and placed in them several times. She is a recreational judo player. You know why? BECAUSE SHE IS #@!ing ELEVEN YEARS OLD!

I am probably going to judo hell for this but when I was in Boston this week I did not take my daughter to Pedro's Judo Club, even though they teach very good judo there. I

took her to the Museum of Science and the New England Aquarium. Although she made an 'A' in science, I was not too pleased with her standardized test scores and I thought she might benefit more from seeing a scaled-down model of the solar system and learning about marine life. We also spent a lot of time in the pool and babysitting my granddaughter, Eva.

Do you see those two people in the picture? Only one of them is an elite athlete but they both do judo and I love them both. This ad has been brought to you by reality.

Please, please, please, if you are a player, or a coach, or a parent, trade in all the medals for a share of stock in reality. Love your children, value everybody on your mat, because those people you are lavishing all of your time on because they are this year's silver



medalist in the senior nationals or a three-time junior national champion at age ten - they aren't much more likely to win world medals than that 40-year-old.

Coincidentally, I ran across an article today in Black Belt Magazine from 1975 about women's judo. My name isn't mentioned anywhere. My coach's name certainly isn't mentioned. I was 16 years old and did not even compete in the senior nationals. I was a freshman in college at the time and it never even crossed my mind to go because I could not afford to travel across country.

So, is my point that those recreational players are worth attention because some of them might turn out to be a world champion, like I did? No. My point is that I wouldn't have BEEN a sixteen-year-old college freshman if it wasn't for the good influence of my recreational judo coaches.

Everyone who steps on that mat is important. That's reality. The next 30 pages of results, tournament announcements, clinic reports, invitations for award recognition, upcoming clinics and conferences – that's all for you. All of you.

Shime waza

One only needs to turn on the TV today to see the influence that Mixed Martial Arts (MMA) has played in forming American psyche and how it views martial arts. Its competitors, from many diversified backgrounds in all martial arts, have caught the interest of both fans and actual martial arts practitioners. While MMA has some interesting techniques that we can learn from, we don't believe most of Judo and Jujitsu practitioners would want their students to go to its extremes. Thus, Judo and Sport Jujitsu competition keeps it in a safe, manageable arena. Since we are practitioners we tend to look at it to see what we can derive from it for legal use in class or competition. When you watch MMA, one of the first things that you notice is that a great many of the competitors come from Judo or Jujitsu backgrounds. Another observation is that many of the MMA matches end due to an applied choke. Since it has been estimated that only 4% of judo matches are won by chokes, *Shime waza* appears to be an under-utilized area in competition where we can enhance our skills. Remember, a properly applied choke can end a match just as fast as a clean throw.

The school we come from and have each trained at for the last 40 years, Cahill's Judo Academy in San Bruno, California is rich in both Judo and Sport Jujitsu competition. Coach Willy Cahill has always stressed that as a competitor or instructor you should be as well-rounded as possible.

Observation has shown us that students tend to get in a "comfort zone" by practicing what they do well. For some students, chokes are not in that comfort zone and, thus, are rarely practiced by those students.

Here are two simple, yet very effective, chokes which are both legal for Judo or Sport Jujitsu:

1) Gyaku Eri Jime (Reverse Lapel Constriction) – lariat strangle.



You can enter into gyaku eri jime with the left hand reaching across to the opponent's opposite lapel. The right hand shoots up past the opponent's head and grabs the gi on the opponent's left shoulder with close grips to maximize the effectiveness of the constriction. To apply, close the grips and arms together around your opponent's neck, which applies direct pressure to the carotid/jugular triangle and across the trachea, achieving both a strangle and a choke.

Another entry is to start with a high grip with the right arm on the opponent's gi on the left side. As the opponent shifts their head beneath this arm, shoot the left hand across and grab the opponent's lapel, and then tighten the arms to apply the constriction.

2) Koshi Eri Jime (Hip Lapel Constriction) – sitting on shoulder or walking around.





For this technique, start with the choking hand at the opponent's ear and follow the jaw line, applying moderate pressure. This is usually uncomfortable enough that the opponent lifts his head, allowing you to slip your hand to the opponent's opposite lapel. To apply pressure, use your gripping hand to penetrate into the carotid/jugular triangle while you sit on the opponent's shoulder to apply further pressure into the constriction.

In Sport Jujitsu, the rules are somewhat different in that they allow some additional chokes and entrances. For instance, to gain entrance for the choke in Koshi Eri Jime, you're permitted to slide your hand under the opponent's nose to raise the head and open up for a deep grip, besides access along the side of the jaw. Guillotine chokes are permitted from standing or from ne waza, though they aren't allowed during a throw.

While the rules for chokes in Judo competition and Sport Jujitsu differ somewhat, these basics apply to all chokes:

- 1) Get in as deep as possible, as soon as possible. If the hand position is too deep, it's easy to loosen to get to the proper position, but almost impossible to advance, once the opponent realizes the intention.
- 2) Take out all the slack. Space between the hands and the neck creates a weak choke.
- 3) Be aware that chokes apply pressure from at least two directions, so depth and removal of slack don't necessarily make a good choke.
- 4) An effective choke doesn't necessitate it being complex. Start simple and progress towards the more difficult.

USJA Coach Certification Clinic

A FUN DAY IN LA

On Saturday, October 17th Judo Instructors from four states came together to participate in a USJA Coach Certification Clinic, hosted by Wall to Wall Martial Arts, in Watson, LA.



Clinicians included James Wall – Wall to Wall Martial Arts, Jeff Miller – Acadian Judo, and Jim Hunt – Gulf Coast Judo. The day was very busy as participants moved between classroom sessions and mat sessions. Classroom sessions covered subjects such as Using Lesson Plans, Jr and Sr Handbooks, Safety and Legal Concerns, and Character Development. One classroom session of particular interest covered the recognition and treatment of common Judo injuries and was led by Jim Hunt of Gulf Coast Judo who is also a licensed Physical Therapist.



Mat sessions covered Traditional vs. Sport Specific warm-ups and *Ukemi*, basic *Ne Waza* pins and escapes, grip fighting, and *Tachi Waza* (throwing) techniques. Many participants remarked that they enjoyed the *Tachi Waza* portion which was a slight departure from the norm. Participants were broken up into small groups and each group was given a list of various throwing techniques. The groups then had 20 minutes to go over the throws with other members in their group. Then each person was asked to teach one technique from their list to the entire class. Lower ranked group members went first with the teaching and everyone seemed to enjoy this slight reversal of normal roles.

Overall it was another fun day of Judo in LA!

We solicit recommendations from every club for each of 11 categories. If your kata nominee performs always with the same partner, nominate both, since they earned the same number of points. Your nominees will be considered objectively along with others from your state, using the recommendation form point system. In case of a tie the Committee will make the selection. To be considered, recommendations must include the necessary information and meet the March 31 mailing deadline. Make recommendations based on activity for the entire calendar year. You may nominate someone not a USJA member if you include membership application and fee.

Remember, if you don't recommend anyone, you preclude your players even from entering the awards competition. Sometimes only one club in a state will submit nominations. Though such nominees may have few points, they have more than anyone else in their state, since those not submitted cannot be counted. You may nominate yourself or someone from another club.

Begin thinking now of whom you might nominate. Make certain those individuals keep competition records current. Tabulate points with your nominees' assistance. Simply giving the form to a judoka does not guarantee that I will receive it. Finally, watch the deadline. Some deserving nominees do not receive recognition because they miss the deadline. Make certain that those you nominate are current USJA members or that you send in USJA membership forms and fees along with your recommendation.

I look forward to receiving your recommendations. Thank you for participating. Those whom you recommend will be grateful to you for honoring them in this fashion. Names of those selected will be posted in our Hall of Fame on the USJA website, along with the coaches' names.
